Demo Requests

Requesting demo equipment is easy via the Partner Portal. After logging in, please navigate to the Demo Request section.

Use the shopping cart interface to add items to your cart for a demo request. Products may be added in quantities of 1 at a time. For certain products there are multiple configuration options. Please use the dropdown menu to select desired configuration.

After adding all items to the cart, please use the Notes section to provide End User information and any applicable preconfiguration notes. Then click “Confirm Request” to continue to the next step. Delivery Details should be where the demo equipment needs to be sent. Delivery method is always free. Double check your Order Summary and read the Terms and Conditions. Place Order to complete.

If you have any trouble filling out the Demo Request, please feel free to call us at 800-648-4452 and we can help you finish the request.

Once the request is submitted, an AML sales rep receives an email to verify the information and approve the request. You will be contacted by our team within one business day to confirm all details. A shipping ETA will be given at this time.

Unless other arrangements are made, demo equipment may be kept for up to 30 days, after which time it must be returned or paid for.

Registering Opportunities
